- Grant writing was discussed, Bob is currently in contact with a professional grant writer, and she is to find what is available for our district and is to contact in the near future regarding possible grants.

- Cole Camp Chamber, Bob had been in attendance for a Chamber meeting and was given information that it would cost the district \$100.00 Yearly to join, upon board discussion they decided to join the Chamber with Tom Gage making a motion to join with a Seconded by Eric, Motion carried.
- GEMT wire transfer and funds, it was presented to the board that this year's GEMT funds were available, and that district would need to set up a wire transfer by April 14<sup>th</sup> with a amount of \$17,552.25. The total amount given back to the district would be \$50,281.68, the board decided to proceed with the wire transfer

with Daniel presenting a motion for the wire transfer with a seconded by Tom Gage, the motion was carried.

- Work Comp Bids were presented with 2 bids with Missouri Employers Mutual with a bid of \$9,200.00 and a bid with Mike Keith insurance of \$13,447.00, the coverage would be the same with either company, the board did discuss the bid and a motion was made by Eric to go with Missouri Employers Mutual with a seconded by Ed Welch, Motion carried.
- Meeting date for the April meeting 2022 will be on April 18th, 2022, at the Ambulance Base.

# **ADMINISTRATOR'S REPORT**

• Donnie reported total runs last year were 43, with 25 transports, 13 patient refusals and 5 service calls. This Year 37 calls, 29 transports, 7 refusals, and 1 service calls.
